(WHEREAS, THE PUBLIC HEARING
4 BEFORE THE POLAND TOWNSHIP BOARD
5 OF ZONING APPEALS, IN CASE
6 #ZA-01-25, COMMENCED ON
7 WEDNESDAY, MAY 7TH, 2025, AT
8 7:00 P.M. FIRST ON THE AGENDA,
9 THE 2025 REORGANIZATIONAL
10 MEETING WAS HELD. RICKY
11 MORRISON MADE A MOTION TO
12 NOMINATE MICHAEL JOHNSTON AS
13 CHAIR FOR CALENDAR YEAR 2025.
14 JOHN GRAHOVAC SECONDED THE
15 MOTION. THERE WAS A UNANIMOUS
16 VOTE IN FAVOR, WITH MICHAEL
17 JOHNSTON ABSTAINING -- ROLL CALL
18 VOTE: 4, AYE; 0, NAY; 1,
19 ABSTAINED. MICHAEL JOHNSTON
20 THEN MADE A MOTION TO NOMINATE
21 RICKY MORRISON AS VICE-CHAIR FOR
22 THE CALENDAR YEAR 2025. ROBERT
23 DURICK SECONDED THAT MOTION.
24 THERE WAS A UNANIMOUS VOTE IN
25 FAVOR, WITH RICKY MORRISON

1 ABSTAINING -- ROLL CALL VOTE:
2 4, AYE; 0, NAY; 1, ABSTAINED.
3 WHEREAS, MICHAEL JOHNSTON TOOK A
4 MOMENT TO WELCOME ARTHUR "BUZZ"
5 KELTY AS A NEW MEMBER OF THE
6 POLAND TOWNSHIP ZONING BOARD OF
7 APPEALS FOR 2025. WHEREAS, THE
8 NEXT ITEM ON THE AGENDA WAS
9 APPROVAL OF THE MINUTES FROM
10 DECEMBER 5TH, 2024, CASES
11 #ZA-11-24 AND #ZA-12-24. A
12 MOTION WAS MADE BY MICHAEL
13 JOHNSTON TO APPROVE BOTH CASES'
14 MINUTES CONCURRENTLY. SECOND BY
15 ROBERT DURICK. THERE WAS
16 APPROVAL OF THE MINUTES, WITH
17 JOHN GRAHOVAC AND ARTHUR KELTY
18 ABSTAINING -- INDICATING THAT
19 THEY WERE NOT IN ATTENDANCE FOR
20 THOSE CASES. ROLL CALL VOTE:
21 3, AYE; 0, NAY; 2, ABSTAINED.
22 WHEREAS, NEXT ON THE AGENDA,
23 MICHAEL JOHNSTON, CHAIRMAN, THEN
24 INTRODUCED ZONING CASE
25 #ZA-01-25, FOR MAY 7TH, 2025,

1 AND READ THE LEGAL NOTICE INTO
2 THE RECORD, AND GAVE A BRIEF
3 BACKGROUND ON THE CASE. THE
4 APPELLANTS, CHARLES AND SHERRY
5 KISH, PRESENTED THEIR CASE TO
6 THE BOARD. THE BOARD INQUIRED.
7 EVERYONE WAS GIVEN AMPLE
8 OPPORTUNITY TO SPEAK. GREGG AND
9 ROSA RICHLEY, ABUTTING PROPERTY
10 OWNERS, WERE IN ATTENDANCE,
11 ASKED QUESTIONS -- AND REQUESTED
12 THAT A FENCE BE INSTALLED FOR
13 PRIVACY. THE APPELLANT
14 ADDRESSED QUESTIONS AND CONCERNs
15 RAISED. AN AGREEMENT WAS
16 REACHED, BETWEEN THE APPELLANTS
